I have read your letter dated March 20, 2015 regarding your plan and I am not fully understanding about this plan. Maybe my english still not good enough to wrote clearly.



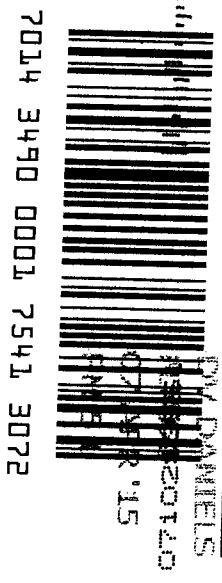
I have do my best to reply and I have no idea how I helping the plan without any working background and knowledge, also I don't have any relatives, friends worked at this field.
